

GENERAL RELATIONSHIP AGREEMENT

This agreement ("Agreement") establishes a relationship ("Relationship") between the following parties:

Marijke Jean Dixon

Kenneth Michael Merrill

and is undersigned and set forth this **1st of February, 2013** for a period of three (3) months. Ratification of this document by K5M Shareholders will serve as an amendment to any previous shareholder agreements. The undersigned parties hereby agree to the following provisions as conditions of the Relationship:

SECTION 1--Partnership Outline

- 1.1** The Relationship between both parties will be named a "Couple", for the purposes of an exclusive romantic relationship.
- 1.2** The title of Marijke Jean Dixon will be "Girlfriend" and the title of Kenneth Michael Merrill will be "Boyfriend".
- 1.3** Relationship shall commence on the date listed above, and will end after a period of three (3) months, or sooner based on mutual agreement or per the terms listed in the Section 16--Relationship Withdrawal or Death.
- 1.4** The Couple agrees to consider renewal/renegotiation upon the completion of the contract terms.

SECTION 2--Privacy & Trust

- 2.1** Passwords and login information will not be shared except for the following, at the discretion of the owner:
 - a. WiFi node passwords
 - b. iPhone security number
- 2.2** Couple will share their location via *Find My Friends* service.
- 2.3** Key Buddies
 - a. Couple will exchange keys to one another's residence.
 - b. Entry will be permitted under the following conditions:
 1. The intruding party is expected.
 2. Express permission has been granted.
 3. The intruding party intends to do secret good deeds.

4. It's an emergency.

SECTION 3--Evaluations

- 3.1 A review of the performance of both Boyfriend and Girlfriend shall occur at month end.
 - a. Review will be a self-assessment conducted by the Couple.
 - b. Review will evaluate the status of the relationship based on personal, social, sexual, intellectual and emotional growth.
 - c. Any area(s) determined to be lacking must be addressed with a suitable plan of action. This process will be documented and shared with shareholders.
- 3.4 Couple shall give honest critique in order to assist each other in being the best version of themselves.

SECTION 4--Social Obligations and Responsibilities

- 4.1 Girlfriend must make acceptable efforts to attend and demonstrate full engagement in at least one (1) social obligation per week that Boyfriend invites her to attend.
 - a. Should multiple invitations be made, Girlfriend retains the right to choose which events are attended.
- 4.2 Boyfriend must make acceptable efforts to attend and demonstrate full engagement in at least one (1) social obligation per week that Girlfriend invites him to attend.
 - a. Should multiple invitations be made, Boyfriend retains the right to choose which events are attended.
 - b. Social obligation shall not infringe on any previously scheduled shareholder or project-based obligation.
- 4.3 Couple shall be punctual when meeting one another.

SECTION 5--Fiscal Accountability

- 5.1 During the course of the relationship, the Couple will support efforts to act in a fiscally responsible manner.
- 5.2 Either party may, at their own discretion and without cause, institute an Equal Pay Policy (EPP)
 - a. EPP requires that all Couple expenses are split on the basis of relative income.

- b. EPP requires that all costs to be split are recorded and kept on file for a minimum of two (2) weeks
- c. Once EPP is instituted it shall remain in effect for the duration of the contract.

SECTION 6--Attire

- 6.1** During the course of the contract, Girlfriend must acquire and incorporate into her wardrobe one (1) item of Brooks Brothers clothing, shoes or accessories.
- 6.2** Boyfriend shall limit the wearing of a bow tie or loud plaids to the following occasions:
 - a. Formal Friday, political events, weddings, television appearances, mini-golf, party or event hosting duties, and attendance of sporting events.
- 6.3** Neither party may wear flip-flops in one another's presence.
 - a. exceptions include: when assigned flip-flops (spa, etc.) and safety/emergency (Die Hard, etc.).
- 6.4** Neither party may wear blue jean pants, except when performing physical labor.
- 6.5** Both parties will maintain clean physical hygiene and work to routinely present their best self.

SECTION 7--Diet

- 7.1** Boyfriend and Girlfriend must attempt to prepare a majority of their meals at home, together or separately.
- 7.2** Couple shall be open to eating foods the other encourages, provided;
 - a. There are no health hazards associated with the food,
 - b. The food is being eaten by both members of the Couple.

SECTION 8--Physical Maintenance

- 8.1** The Couple must floss a minimum once daily.
- 8.2** The Couple must demonstrate a commitment to physical fitness with the purpose of consistent improvement in health and appearance.

SECTION 9--Media

- 9.1 Girlfriend will share any “fancy magazines” she acquires with Boyfriend (The Gentlewoman, Apartamento, etc.)
- 9.2 The Couple will watch a minimum of one (1) movie together each week.
- 9.3 iPhone usage will not be restricted in each other’s company, except in the instance of driving (see 10.6).

SECTION 10--Driving

- 10.1 As owner of the primary vehicle to be used in the relationship, Girlfriend retains the option to designate the driver at all times.
 - a. If at any time Boyfriend becomes the owner of a vehicle that is subsequently used in the course of the relationship the option to designate the driver at all times will be nullified.
 - b. If at any time Girlfriend sells her vehicle and does not replace it with another the option to designate the driver at all times will be nullified.
- 10.2 When given verbal permission, Boyfriend is allowed to borrow Girlfriend’s car.
- 10.3 Boyfriend is not allowed to drive Girlfriend’s car over 80 MPH without verbal permission.
- 10.4 Boyfriend can “Run The Loop” in Girlfriend’s car no more than one time per calendar month.
- 10.5 Any damage or fines caused by driver negligence are the responsibility of current driver, or in the case of parking citations, the driver who parked the vehicle.
- 10.6 Both parties shall refrain from any communication via the phone (calls, texts, emails, etc.) while driving, excepting communications via Siri.

SECTION 11--ATF Policies

- 11.1 The Couple will limit alcohol consumption unless one or more of the following conditions apply:
 - a. It is a festive atmosphere.
 - b. It eases excessive pain (physical, social, or emotional).
 - c. Participation in drinking games where more than \$50 is on the line.
- 11.2 The Couple are allowed one (1) tobacco consumption session per month each.
 - a. Non-exercised sessions cannot be accumulated for later use.
- 11.3 When operating a firearm the Couple agrees to:
 - a. Always keep the gun pointed in a safe direction.

- b. Always keep finger off the trigger until ready to shoot.
- c. Always keep the gun unloaded until ready to use.

SECTION 12--Behavioral Restrictions

- 12.1** Boyfriend will ensure his residence is clean before girlfriend visits.
- 12.2** Boyfriend must act in a gentlemanly manner.
- 12.3** Girlfriend must act in a ladylike fashion.

SECTION 13--Sex

- 13.1** Sexual relations, with the goal of mutual satisfaction, must take place at minimum three times per week excepting periods of illness, separation, and conditions which prevent the enjoyment of sex.
 - a. Should sexual relations cease for a duration of longer than two (2) weeks the non-interested party shall engage in limited sexual contact for the pleasure of the interested party at their request.
- 13.2** Nicknames will not be given to genitalia.
- 13.3** Sexual relations will be conducted solely for pleasure with no intent of procreation.
 - a. Precautions will be taken to avoid pregnancy.
 - b. Precautions that affect the body of Girlfriend will be paid for by Boyfriend.
- 13.4** Sexual fantasies, fetishes, and explorations will be conducted under the Dan Savage rule of GGG (<http://tinyurl.com/66z65k>)
- 13.5** Public Display of Affection (PDA) shall be limited to the following: a brief kiss on the hand, cheek, lips; hand-holding; arms around waists/shoulders; a mostly discrete pat on the butt; pinching; friendly punching; extended hugs; "footsie"; tasteful making out in the case of drunkenness, darkness or anonymity.
- 13.6** Pornography restrictions include:
 - a. No porn that is illegal as defined by US law and/or the State law of Oregon.
 - b. No porn in which an acting party is a personal acquaintance, unless watched together.
- 13.7** The Couple will operate as Exclusive and not take additional sexual partners during the course of the Relationship.

SECTION 14--Disputes/Arbitration

Disputes that cannot be settled by the Couple via a mutual decision-making process will be settled by writing to Yours Truly's ADVICE column.

SECTION 15--Stock-based compensation

- 15.1** Upon ratification of the contract, Girlfriend will be granted a call-option for one hundred (100) shares of KmikeyM stock.
- a. Option to be priced at-the-money on contract ratification.
 - b. Option will be vested immediately and have an effective duration of two (2) years.

SECTION 16--Relationship Withdrawal or Death

- 16.1** Should either party wish to leave the Relationship, they must submit a written request with stated reasons to the other party with three (3) days notice prior to any public announcement..
- 16.2** Upon a Partner's death the remaining Partner will enter a period of "Grieving" for length of the relationship to date. Grieving is defined as:
- a. Wearing all black
 - b. No sexual relations with other persons
- 16.4** Should the Couple end the Relationship, willingly or unwillingly, the former couple shall not have a romantic or sexual relationship within one (1) degree of Friendship of the other for a period of six (6) months.
- 16.5** Should the couple end the Relationship, willingly or unwillingly, the former couple shall not speak negatively about the other for a period of three (3) months.
