

RELATIONSHIP DISSOLUTION AGREEMENT
Mutual Release and Non-Disparagement Agreement

THIS MUTUAL RELEASE AND NON-DISPARAGEMENT AGREEMENT (the "Release") is made and shall be effective as of the 5th day of December, 2017 (the "Effective Date") by and between MARIJKE J. DIXON ("Girlfriend") and KMIKEYM a/k/a The Project of Mike Merrill (the "Project").

WHEREAS, Girlfriend was in a romantic relationship with Mike Merrill pursuant to the terms of a Relationship Agreement (the "Relationship Agreement").

WHEREAS, the Project and Girlfriend have agreed that the relationship will be considered terminated on the Effective Date; and

WHEREAS, in connection with that termination, the Project has agreed to assist in liquidation of Girlfriend's Project holdings, subject to the execution of this Agreement.

NOW THEREFORE, in consideration of these premises the parties agree as follows:

1. Resignation.

Girlfriend hereby ends the contractual romantic relationship and any positions held or once held in relation to the Project and any Affiliate Projects including, without limitation, erotic fan-fiction, working groups, hot sauce ambassadorships, snack-based media websites, film, video, or books projects, and any other projects effective as of the Effective Date.

2. Payments.

In consideration of Girlfriend's resignation and in recognition of a good-faith effort, Girlfriend shall receive from the Project:

Purchase for all shares offered on the market at a reasonable price through Effective Date; Encouragement to the shareholders from the Project to accept these offers in exchange for signing the Agreement;

3. Acknowledgements.

Girlfriend acknowledges that: (i) the payments described in Section 2 of this Release constitute full settlement, (ii) she has no entitlement under any other severance, and (iii) except as otherwise provided specifically in this Release, the Project does not and will not have any other liability or obligation to her.

4. Mutual Release.

The Project (including, for purposes of this Section 4, its Affiliates) hereby fully and forever releases and discharges Girlfriend (and her heirs, executors and administrators), and Girlfriend hereby fully and forever releases and discharges Project from any and all claims, demands, liens, agreements, contracts, covenants, actions, suits, causes of action, obligations, controversies, debts, costs, expenses, damages, judgments, orders and liabilities, of whatever kind or nature, direct or indirect, in law, equity or otherwise, whether known or unknown, arising through the date of this Release, out of Girlfriend's relationship or the termination thereof.

5. Covenant Not to Sue.

Girlfriend expressly represents that she has not filed a lawsuit or initiated any other administrative proceeding against the Project. The Project expressly represents that it has not filed a lawsuit or initiated any other administrative proceeding against Girlfriend. Both the Girlfriend and the Project further promise not to initiate a lawsuit or to bring any other claim against the other arising out of or in any way related to the relationship or the termination of that relationship.

6. Non-Disparagement.

The Project will not disparage Girlfriend or Girlfriend's performance or otherwise take any action which could reasonably be expected to adversely affect Girlfriend's personal or professional reputation. Similarly, Girlfriend will not disparage the Project or any of its directors, officers, agents or shareholders or otherwise take any action which could reasonably be expected to adversely affect the personal or professional reputation of the Project or any of its directors, officers, agents or shareholders.

7. Cooperation.

Girlfriend further agrees that she will cooperate fully with the Project with respect to any matter which relates to matters with which Girlfriend was involved during her relationship. Girlfriend shall render such cooperation in a timely manner on reasonable notice from the Project.

The Project or its duly authorized officer, further agrees that they will cooperate fully with the Girlfriend with respect to any matter which relates to matters with which Project was involved during the relationship. The Project's representatives shall render such cooperation in a timely manner on reasonable notice from the Girlfriend.

8. Entire Agreement; Amendments.

Except as otherwise provided herein, this Release contains the entire agreement and understanding of the parties hereto relating to the subject matter hereof. This Release may not be changed or modified, except by a Release in writing signed by each of the parties hereto.

IN WITNESS WHEREOF, the Project has caused this Release to be executed by its duly authorized officer, and Girlfriend has executed this Release, in each case as of the date first above written.
